

Its registered office is Its registered office is B-4608 WARSAGE, Thier Saive, 49; it is subject to the Belgian law of the 25th October, 1919 granting legal status to international associations with philanthropic, religious, scientific, artistic or pedagogic aims..

For a large group of patients with musculoskeletal disorders, the healthcare systems of many countries do not deliver an adequate service either in a timely fashion or at all. This unmet need, in many countries, leads to unnecessarily prolonged suffering and disability, together with economic consequences due lo loss of productivity and drains on welfare, where it is available, as well as inappropriate medical costs.

Identifying this unmet need has led FIMM to devise a training program in order to produce a medical specialist capable and competent to satisfy the requirements of this large patient group, in a focused, timely, evidence-based and economical manner.

This statement was adopted by the FIMM General Assembly 2009.

## General Assembly

- Fractions of 25 99 have 1 vote
- Fractions of 100 1'999 have 2 votes
- Fractions of 2'000 or more have 3 votes

## The right to vote is limited to *Fractions*

- consisting of one or several Ordinary Members
- reaching together a total of at least 25 qualified physicians

After 2023 <u>qualified physicians</u> must fulfil the 300 hours of training in Manual/Musculoskeletal Medicine criteria of the <u>FIMM Guidelines for Basic Training and Safety</u>




## FIMM 1995 - 2017


